## **HOTEL ACCOMODATIONS**

Purchaser shall pay for and provide Artist with seven (7) hotels rooms for two nights (night before and night of engagement) at a first-class hotel to be mutually agreed upon between the Artist and Purchaser.

## **GROUND TRANSPORTATION**

Purchaser shall pay for and provide Artist with all necessary ground transportation required for twelve (12) persons and luggage/equipment, including transportation to and from airport, hotel to concert venue and back, etc. Ground transportation vehicles and schedules are to be coordinated with Darron Moore and/or whomever the Artist designates.

## **AIRLINE TRAVEL**

If airline travel is required, an airfare buyout is preferred. In the event Purchaser is providing airfare, the names of the performers will be provided to the Purchaser.

### **CATERING REQUIREMENTS FOR DRESSING ROOM**

Purchaser will provide the following ONE hour before setup/sound check:

ICE, - Twelve (12) individual-sized bottled water (at room temperature) - Two (2) six-pack of Soda (Black Cherry, Ginger Ale) - assorted granola bars (any flavor) -assorted snack chips (Doritos, Sun Chips, etc.).

HOT tea with Milk, Sugar, Splenda and cups-One (1) deli tray including, but not limited to: sliced turkey; sliced roast beef; sliced cheddar, Swiss and provolone cheeses; assorted breads; pickles, condiments, etc.- assorted fruit (bananas, apples, pineapple, grapes, etc.)

Two (2) bottles of good white wine chilled (Chardonnay) One (2) bottles of good red wine (Cabernet Sauvignon) Two (2) six-packs of chilled beer (Blue Moon) One (1) corkscrew Twelve (12) wine glasses

Four (10) hand towels for onstage)

Hot dinner for twelve (12) persons; serving time TBD on site. Meals to consist of 12 entrees, two side dishes (at least one green vegetable), salad, dinner rolls and beverages. (Meals should be approved in advance by Artist.)
